


Salt Lake City Area Economic Summary

Unemployment rates for the Salt Lake City Area, selected area counties, and the nation



Average weekly wages for all industries by county


Salt Lake City area, first quarter 2019



Over-the-year change in the prices paid by urban consumers for selected categories


12-month percent change in CPI-U, October 2019

Over-the-year changes in the selling prices received by producers for selected industries nationwide


12-month percent changes in PPI


